# FORMAL COMPLAINT

Re: Industrial processing at Godwin's, Peat Works, Burtle Road, Westhay, Glastonbury BA6 9TT

Burtle Parish Councillors would like to make a formal complaint about the way in which Mendip District Council have dealt with the wood chipping activities at the above site and the subsequent delays.

Burtle Parish Council first flagged this matter up in December 2015 and it is still ongoing. I have attached a brief timeline of actions taken in the almost three years since the wood chipping commenced on the site for your reference.

My Councillors asked me to write to you personally on 23 September 2016 to enquire what action Mendip District Council was taking regarding the activities of South West Wood Products on this site as they were becoming frustrated about the apparent lack of action to deal with the matter. In your reply, you confirmed that the Planning Enforcement Department and Environmental Protection Department were looking into the matter but there had been some delay because of illness.

I have been in constant correspondence with your officers but the matter has still not been resolved. In July 2017 Ref: 2017/1838/VRC section 73 application for a minor amendment was made but was withdrawn in November 2017, on advice from the planning officer that it would not be successful. This was after some five months and over seventy letters of objection from members of the public and the many consultees who noted that obligatory impact assessments had not been carried out. In January 2018 we were advised that, following meetings, the applicant intended to submit a CLEUD. Intrigued as to how this could be considered appropriate Burtle Parish Council made a Freedom of Information request for minutes of the meetings. As far as we are aware the CLEUD has still not been received despite being told in May that it was 'imminent'. In fact, the occupants of the site seem to be becoming more entrenched. The piles of wood chippings are being expanded amongst the oaks towards the back and western side of the site and a very large section of hard standing complete with permanent security fencing is currently being developed on the western side of the site.

Councillors feel that Mendip District Council has very little appetite to resolve this situation and would like your comments on the current position and how long you intend to allow the matter to drag on before any enforcement action is taken. Councillors hope that the matter will now be progressed in a timely fashion so that they will not need to consider any further action.
