194 MINUTES OF PREVIOUS MEETING

Minutes of the meetings held on 6th March, 27th March 2019 and the Annual Parish Meeting held on 6th March 2019 were agreed and signed as correct.

196 MATTERS ARISING

Highways – List of items requiring attention to be sent to Highways including: **Badger damage** – Robins Lane. **Road surface** – Halterpath Drove, **Edge erosion** – Westhay Broad Drove and Tile House Road, **Potholes** – Edington Road, **Reflectors and Slow signs** – Redgate, Burtle Road. New lake by the Peat works is also a cause for concern as it is very deep now and the condition and angle of the road would make it very easy to lose control and enter the water, particularly as the road is often covered in mud. Cllrs have asked whether a safety barrier could be erected. There is a similar situation on the Burtle side of the peat works where the vegetation has been cut back exposing a deep rhyne.

Drainage – nothing to report

Catcott Broad Drove – Caravan and storage container at Honeysuckle Villa must be removed by 2nd May 2019

Sign on Sandpit and Finger Posts – ongoing

Village Spring Clean – had to be postponed from 7th March because of unsafe weather conditions and will now take place on 10th April 2019.

CIL payment Burtle Inn – enforcement action is in abeyance at present as developers have lodged an appeal with the Planning Inspectorate.

Grass cutting – Draft schedule of grass cutting 2019/20 was agreed. Clerk to send copy to all those interested in quoting to carry out the work.
