155 MATTERS ARISING

Highways – Highways will keep state of the road by Sweet's Corner under review but are happy with the number of reflectors. Highways to contact owners re barbed wire which has been erected right on the Highway at the peat works. Scaffolding at the Burtle Inn is licensed by Highways but contractors have been asked to improve safe access to the post box.

Drainage - work has been completed up to the pond in Robin's Lane

Catcott Broad Drove –Highways Dept that believe that occupants of horse box have discontinued the practice of laying a cable across the road. Cllrs believe that this is still going on.

Bus Shelter – resurfacing of the area in front of the shelter is ongoing. Wood work on side of shelter needs attention. Cllrs to assess.

Sign on Sandpit and Finger Posts – Cllrs agreed to research new signs for Sandpit as old ones have both rotted at the base.

Road signs – SLOW signs to be requested for Redgate after consultation with local farmers.

Defibrillator – Sixteen people took part in Annual Awareness training alongside Café Burtle on 10th February 2018. Thanks to Nathan Chard for his help on the day.

SIDs –Cllr a Duval attended meeting about self-funding of SIDs after March 2018. Still awaiting further information about options.

CIL update Presentation notes have been forwarded to Cllrs. There may be some funding due from Burtle Inn development.
