132 MINUTES OF PREVIOUS MEETINGS

Minutes of the meetings held on 4th and 11th December 2019 were agreed and signed as correct.

133 REVIEW OF ACTIONS FROM PREVIOUS MEETING

134 MATTERS ARISING

Highways – Cllrs pleased to note that pothole in Catcott Broad Drove has been repaired. Clerk to inform Highways Dept. that drain at the Cross by Watts Farm is ineffective as it is higher than the road surface also road surface is breaking by the Sandpit.

Still some trees overhanging the Highway in Robins Lane. Land owner to be made aware. Contractors are continuing with building up the sides of the road in Westhay Road. No drainage channels have been constructed clerk to write to make Highways aware.

Bridge Dept are aware of damage to bridge in Catcott Broad Drove. Clerk has contacted Somerset heritage for help to retrieve the historic plaque on the bridge. Cllrs are willing to clean and repaint the notice as a piece of Burtle's history.

The pond in Robins Lane is overflowing and water is flooding the road. This was reported to drainage Board and Highways Dept some two years ago but not resolved. Clerk to contact them again.

District Cllr Stuart Kingham's enquiries regarding the safety of deep-water lake beside the peat works are still ongoing. Cllrs feel that a safety barrier is needed. The Mendip District Councillor for Meare and Westhay, Matt Martin, was present and will also take the matter up as the lake is actually in Westhay.

CIL Payments for Burtle Inn development still outstanding.

Notice boards Cllr N Ponsillo has inspected the noticeboard by the postbox and has reported that it is looking a bit tired but is still useable. Cllrs unanimously agreed to review and repair as necessary all three noticeboards in the Spring.

The chairman agreed to bring the next item forward to allow District Cllr M Martin to attend another meeting.

135 WOOD CHIPPING OPERATIONS

Mendip District Cllr Matt Martin informed the meeting that, following the withdrawal of the appeals, the Ashcott Road site is being cleared. The Meare group are now looking at the Godwin's site which is in their Parish. Burtle Parish Council has already copied some correspondence regarding the Westhay site to District Cllr Martin but they offered to share any further correspondence from their files about the site. He agreed to keep Burtle Parish Council informed of any progress.

138 SSSI LAND AT WESTHAY BROAD DROVE

Liam Gill, Highways Dept has now inspected the area and has removed some unauthorized fence posts. He has written to the owners of the central plot and asked them to remove the barbed wire fence or respond to his letter by 6.1.20. Clerk has written to ask for an update but he has not replied to the enquiry. There has been a lot of activity on the section nearest to Westhay. Steve Parker at Natural England has been informed and he is pursuing the matter. Unfortunately, contact from Environment agency who was dealing with this matter has now left.

139 TRAFFIC THROUGH THE VILLAGE

Cllr D Huxtable was not present at the meeting but reported that his December meeting with the Traffic Engineer had been cancelled and so he had been unable to take up the Parish Council's continued requests for road markings. This matter has been ongoing for two years now.

140 FINGER POSTS

Some grant aid may be available for the renovation of the post at the Cross. Clerk to pursue with Somerset heritage. The post by Black Bull Bridge has been renovated by Mark Parish Council but as the border is so convoluted at this point Cllrs unanimously agreed to make a donation to cover half the cost of the work with Mark Parish Council. Mark PC have advised that the cost of this renovation was £550 but clerk to check whether this included VAT.
