19 MATTERS ARISING

Highways – Hole in the bridge at Halterpath Drove has still not been repaired. Clerk to report hole in the road near to historic badger activity in Mark Road near to Lilac Farm and leaning 30mph sign at Lowland Farm. Trees and vegetation overhanging the highway in Catcott Broad Drove is causing vehicles to drive over the opposite verge damaging the edge of the tarmac.

CIL Payments re Burtle Inn site still being under review by Sedgemoor. £175.44 was paid in July and Burtle Parish Council will receive the meaningful proportion of this, £26.32 in October. An amount in excess of £19,000.00 remains unpaid and the 'stop notice' is still in place for the restaurant end of the development.

VE day Clerk will deliver them to young people in the village with a suitable note.

Enforcement issues reply has been received from Sedgemoor DC as follows:

- **Catcott Broad Drove** persons living in buildings behind black gates, it appears that this site has been vacated but buildings next door are being investigated.
- **Catcott Broad Drove** Horse Box by side of the road being used as a residence case has been closed and referred to Highways Dept as it is on the Highway verge.
- **Burtle Inn** building not in accordance with agreed plans, matter is still being investigated.
