13 TRAFFIC THROUGH THE VILLAGE AND ROAD MARKINGS

Extensions to poles that Traffic Engineer required before a Speed indicator device could be placed on them have now been fitted. However, Cllrs were extremely disappointed to learn that new pole that Traffic Engineer required by Sunset Bay Farm and that Cllrs had been told would be erected before the end of the last financial year had not been ordered at all! Assurances have been made that this will be installed as soon as possible.

CiL Somerset Council is pursuing the payment of CiLmoney on the new build part of Burtle Inn as the property has been sold without the person who claimed the self-build exemption has not lived in the property.

Street Party for Coronation Organisers have provided risk assessment required by Insurers in order that the Parish Council's Insurance can cover the event.

Defibrillator Nathan Chard, our Defibrillator Guardian, has requested replacement pads as the current ones go out of date in July. He has also agreed to give an update session at the July Café Burtle.
