36 MATTERS ARISING

Highways Concerns about the deterioration of the road surface in Mark Road by Sweets corner and near to the canal bridge in Halterpath Drove have been reported to Highways. No response to date Clerk to remind. It has been noticed that the recurring dip in Edington Road outside of Hillview is coming back again. Clerk to inform highways

Plaque for Bow Bridge repairs to bridge still awaited

Safety by deep lake and corners by Godwin's Burtle Parish Council has been highlighting their concerns about the safety of the corners on the Western and Eastern side of the peat works. Some white lining, slow signs and reflector posts etc. were installed around the entrance to Honeygar Farm last year when Somerset Wildlife Trust moved in. This has helped on the eastern side but as the Traffic Engineer has made it clear that no further lining or reflector posts will be installed around the Peat works. Burtle Parish Council has had to accept that their efforts to improve the safety in this area have not been successful.

Parish Council Noticeboard has been repaired and refurbished and has now been installed at the front of the hall under the canopy. This will give protection from the weather for those reading the notices and the fabric of the noticeboard. It will also mean that that people reading the notices will be further away from the road. Thanks to Cllrs J Porter, J Hedges, N Ponsillo and R Dallimore who carried out the work on a voluntary basis.

Dog waste bin waiting to hear if general rubbish bin by bus shelter is on list to be emptied by Clean Surroundings. Public continuing to fill it with dog waste.

Encroachment on to Highways Reply has been received from Liam Gill confirming that he has had the area inspected and there has been an encroachment on to the highway verge at 1 Robins Lane and the matter will be dealt with when time and resources allow. He does not believe that there are any other problems with the verges in the village.
