79 TRAFFIC THROUGH THE VILLAGE AND ROAD MARKINGS

Speed Indicator Device is being rotated around the village to the approved locations. New pole for SID in Burtle Road near to Sunset Bay Farm has now been moved to a location out of the hedge where it is able to be used by Somerset Highways. Now that all the work has been satisfactorily completed Councillors agreed to review the invoice issued by Somerset County Council in December 2022 with a view to making payment.

Councillors agreed to purchase a bin to be located near to Black Bull (River) Bridge. Somerset Highways Dept have agreed the location and will fill the bin when it is in place.

81 PROVISION OF DOG WASTE BIN

Somerset Council has now advised that they are unable to enter in to a service contract with Burtle Parish Council to empty a dog waste bin in the village as there is currently a temporary stop on the provision of this service due to restrictions on council budgets. However, if this service was resumed it is unlikely that a contract could be arranged as Somerset Council considers that it would not be cost effective to accommodate emptying a bin in Burtle, due to the distance from work they undertake, around this area. Cllrs agreed that in view of this response there is no point in purchasing a dog waste bin as planned.

Councillors agreed to remove the rubbish bin by the bus shelter at the beginning of December to stop it being used for dog waste and causing a health risk to the children waiting for the school bus. Clerk to put a notice on the bin.

Councillors agreed to purchase two vinyl signs 'Take dog poo home' to put up by the shelter and on the Sandpit.
